Study blasts Tillman's use of taxpayer money



Mell Monroe takes a swing at Tillman

Challenger stages conference in front of alderman's office about last week's Outlook story

In the battle to oust incumbent Ald. Dorothy Tillman (3rd) in the February 2007 election, challenger Mell Monroe threw the first punch at a Nov. 27 press conference in front of Tillman's office about the delegation of her \$1.2 million Aldermanic Menu money in 2004.

Monroe, a Bronzeville businessman, cited the Nov. 22 issue of the Lakefront Outlook, which reported that while Tillman used slightly more than \$300,000 of the fund for infrastructure projects in the ward, she did not spend the remainder, an excess of \$800,000. The unused amount was sent back to the city's general fund.

new study by the University of cago's Cultural Policy Center on economic impact of publicly-ded art questions the benefits of millions of dollars of taxpayer ney spent by 3rd Ward Ald. rothy Tillman on Bronzeville's blic art and the Harold Washington tural Center (HWCC).

ablished Nov. 27 by the Journal of s, Management, Law and Society, study — authored by professor and Grams of the university's Harris adol of Public Policy — noted that alle Bronzeville's property values procketed, the construction of the nural center has not brought significant numbers of tourists into the ghborhood and that the neighborhood's limited infrastructure impedessess to public art and culture.

he study said Tillman ignored policy ommendations made in 1993 by the icago Department of Planning and

Development that identified 43rd Street as the area's best site for a blues district because it was the location of Muddy Waters' house and the original location of the Checkerboard Lounge. Instead, the study said Tillman spearheaded efforts to construct a blues district along 47th Street near the 3rd Ward office headquarters located in a building Tillman owns at 4645 S. King Dr.

Tillman's office is less than one block from the HWCC, the 40,000-square-foot building located at 4701 S. King Dr., built with more than \$10 million in taxpayers' money and run by Jimalita Tillman, the alderman's daughter.

Grams' study noted that almost all of the public money for art and cultural projects in the area had been spent at or near the cultural center — a phenomenon the study characterized as the "kiss the ring tactics" of the ward's powerbrokers.

The study noted that while the area immediately surrounding 47th Street

and King Drive is now thriving, other areas of Bronzeville remain stagnant. It noted the importance of small businesses and art venues in other areas of the community for the long-term financial viability of the cultural center.

"What do they think is going to happen? That people are just going to show up?" the study asked. "The alderman wants to control things. If they (the ward's political powers) would have allowed the people to use their entrepreneurial skills, Bronzeville would have been done by now. All those empty spaces, all those buildings, that district on 43rd Street would have been done by now. They are blocked by the 'kiss the ring' concept. That is, if you don't get the alderman involved, get her sponsorship, if you don't give them a piece of it, it doesn't happen."

Tillman did not return telephone calls seeking comment.

He referred to street lighting and four bronze statues that stand on the corners of 47th Street and King Drive and said that those improvements were done to increase the property values surrounding her ward office, 4645 S. King Dr., the Harold Washington Cultural Center (HWCC), 4701 S. King Dr. and the Spoken Word Café, 4655 S. King Dr.

Jimalita Tillman, the alderman's daughter, is the owner of Spoken Word and is the HWCC's executive director.

The politics of Bronzeville's infrastructure improvements

Financial documents obtained by the Lakefront Outlook under the Illinois Freedom of Information Act may support the study's assertions.

An examination by the newspaper of Tillman's management of her Aldermanic Menu program spending — a \$1.2 million fund for ward infrastructure improvements given to each of the city's 50 aldermen — showed that the majority of the money spent in 2004 and 2005 paid for projects at or near the cultural center.

In 2005, Tillman used \$570,000 of her infrastructure funds to supplement construction costs of what she has long promised will be a small park adjacent to the cultural center, which Tillman has said will honor either music educator Walter Dyett or music composer Quincy Jones. More than \$12,000 of the \$62,759 spent from the fund for light pole painting was used for work near the cultural center, and \$190,000 of the \$547,500 spent on improved street lighting in the 3rd Ward was for improvements on streets near the cultural center.

John Paul Jones, the director of community outreach for the non-partisan Neighborhood Capital Budget Group (NCBG), said Tillman had failed to meet the needs of her constituents by consistently focusing infrastructure improvements in her ward on developments near 47th Street and King Drive.

"This is a critical time for the Third Ward, and residents to inform and direct the alderman as to where this spendshould be targeted," Jones said. "Property values continue grow in that district and homeowners continue to pay his property taxes but are not getting the basic improvements of the alderman to which they are entitled. There are many meeds in the community than just those at 47th and King."

BGA: much of the ward 'neglected'
The Outlook previously reported that in 2004 Tillman fato use much of her \$1.2 million fund for infrastructimprovements, which was returned to the city's general fund fact, Tillman was criticized by the NCBG for failing work with residents to identify and fund infrastructimprovements in her ward after she returned \$883,877 to city from her menu fund after paying for more than \$300, for improvements at 47th Street and King Drive.

Jay Stewart, the executive director of the non-partisan Be Government Association, noted that property owners near intersection — including Tillman — were disproportional benefiting from improvements made at the intersection other areas of her ward want for infrastructure improvements.

"Certainly those property owners are going to see to investments increase because of these improvements stewart said. "But what really is the bigger issue here is so much of the money she is spending is targeted for this narrow area while the rest of the ward's needs go underssed. I can't imagine you can find anyone in Bronzey who will say the only area that needs improvement is at a Street and King Drive."
